





This chart shows the payments in/out of your accounts, over the reporting period.







It takes into account the values of all underlying assets, interest and dividends, fees and charges including adviser fees and charges paid to Quilter, plus the contribution or withdrawal of capital and its timing.

For ISAs the performance does not allow for tax reclaims that have been available at various times in the past.

Fund % growth is calculated using bid prices with income re-invested back into the fund net of tax. For fund or sector average benchmarks the % growth is also calculated net of tax.
