I am writing to you because you are invested in the JPM US Equity Income fund, provided by JPMorgan Funds Limited.

What is changing

JPMorgan has decreased the AMC for the fund from 02 September 2024. Fund managers apply an AMC for the investment management they provide. This is reflected in the pricing of the fund and not taken directly from your holdings.

The Ongoing Charges Figure (OCF)/ Total Expense Ratio (TER) represents the ongoing charges for the fund, expressed as a percentage. It is the sum of the AMC and all other running costs of the fund. OCF is increasingly replacing the TER.

You may want to speak to your financial adviser about the impact of this change. Please speak to them before making any investment decisions, or if you have any questions about this change.

If you don't have a financial adviser, we recommend that you consider the benefits or receiving professional financial advice, which can be especially important when you need to make investment decisions. What this change means for you

The 'reimbursed amount' for the fund is decreasing – We receive a rebate form the fund manager in respect of the fund. This is effectively a discount that we negotiate on the fund manager's AMC. We reinvest part of the rebate as a 'reimbursed amount' into your account. You can see more details of this in the 'Customer Account Credit' section of your quarterly statements.

The effective OCF/TER is the Ongoing Charges Figure/Total Expense Ratio less the reimbursed amount.

This table shows the current and the new amounts once the change has completed.
